RE: TC Ravenswood, LLC Black Start

Dear Mr. Gioia:

In order to address concerns raised by the New York State Reliability Council ("NYSRC") with respect to reliability, TC Ravenswood LLC will provide Spot Black Start service in accordance with its Spot Black Start Services Rate Schedule ("Rate Schedule") in Docket ER12-1418. In addition, TC Ravenswood will voluntarily take the following actions as long as its Rate Schedule, or Superseding Rate Schedule remains in effect and a Customer is taking service pursuant to such Rate Schedule or Superseding Rate Schedule:

1. Perform a comprehensive test of Unit 30 prior to June 1, 2013;
2. Perform a test for Units 10 and 20 in accordance with Rate Schedule Appendix 3, Paragraph 3, prior to June 1, 2013;
3. In accordance with transmission system operation requirements, provide representatives of the New York Independent System Operator Inc. and Consolidated Edison Company of New York, Inc. notice of and an opportunity to witness the above tests;
4. Certify the results of each of the above tests to TC Ravenswood's Customer in accordance with Rate Schedule Paragraphs 5 and 7;
5. Identify and maintain a list of Critical Black Start Components in accordance with Rate Schedule Appendix 2;
6. Operate, test, maintain and repair Critical Black Start Components in accordance with Rate Schedule Appendix 3 Paragraphs 1 and 2; and
7. Certify to TC Ravenswood's Customer that TC Ravenswood personnel have received black start restoration training in accordance with Good Utility Practice.



RE: TC Ravenswood, LLC Black Start

Dear Mr. Gioia:

In order to address additional concerns raised by the New York State Reliability Council ("NYSRC") with respect to reliability, TC Ravenswood LLC is providing additional information with respect to the black start testing and services noted in its February 6, 2013 letter.

The comprehensive test on Unit 30 will commence when the unit reaches a hot condition at which point it will separate from the transmission system. The unit will be isolated from the transmission system and an isolated cranking path between it and a black start gas turbine unit will be established. The unit will start up using energy and voltage control from the gas turbine unit to energize its internal light and power bus, and be ready to synchronize to an energized transmission system when directed by the Consolidated Edison System Operator. The test will be considered successful if, after isolation from the Consolidated Edison transmission system, the hot steam unit is synchronized to the transmission system, and is firm to the system and operating at minimum load in no more than 8 hours after the completion of the isolation.
