#### 4.5.1. Section 1 Introduction

RSS reviewed a draft of reformatted Section 1.0 Introduction (undated).

Mr. Pfleiderer noted that in this draft a sentence was omitted in the reformatted version that he felt was important and should be retained. He requested the sentence "The NYSRC fulfills this mission through its focus on maintaining the reliability of the New York State Bulk Power System ("NYS Bulk Power System")" be retained in the reformatted Section 1.0 Introduction. RRS agreed to retain this sentence in the reformatted Background, Section 1.11.

After further discussion RRS also agreed to add the following sentences to the reformatted Background Section 1.11:

"The requirements of the NYSRC Reliability Rules apply to portions of the NYS Power System that constitutes the NYS Bulk Power System. Maintaining the reliability of the NYS Bulk Power System provides protection for the entire NYCA system from widespread and cascading outages. Therefore, the reliability of the NYS Power System is dependent on maintaining NYS Bulk Power System reliability through the Reliability Rules." These sentences also comprise the first paragraph of Section 1.24. It was agreed to retain these sentences in both Section 1.11 and 1.24.

Mr. Adamson will make these modifications prior to sending this draft to the EC for their review. (AI-180-2)

With these modifications RRS agreed to send this draft to the EC for their review.

The NYISO will review this draft of Section 1.0 and send comments to the RRS by 9/18/14. (AI-181-3)
