- Legislation Session 2022 Chris no update except 2022 is the second year of the legislation session so all bills from last session carry over. So, these two bills are currently still active.

 - Hydrogen Demonstration NYPA Emma M Emma gave a brief update on project status and committed to come back to the group with actual project details when the demonstration is complete.
- RGGI Update Part 242 Regulations, VA Participation, PA Activity Mike Sheehan, NYSDEC – on track for modeling process. 2Q of next year. VA election might change things. PA and NC still moving forward.

- California regulations: Advanced Clean Trucks (ACT)(https://www.dec.ny.gov/regulations/26402.html) Heavy-duty Low NOx Omnibus, and Phase 2 Greenhouse Gas Standards – NYSDEC. Comment period ending shortly. Advanced Clean Trucks by year-end. Others being assessed.
- EPA Cross State Air Pollution Rule (CSAPR 3) Final Allowance Allocation – NYSDEC Staff – no update. Reconciliation next August 2022. Midwest Ozone Group has challenged CSAPR 3.
 - Q What does SIP Disapproval mean? FIP is in place. DEC can replace it but likely will not. Bob no need to replace it. Who does allocation in future? EPA will allocate using DEC methodology.
- EPA Proposed Methane regulations NYSDEC Staff. Ona comment period closed on July 26, 2021; comments have been assessed. Package routing internally right now for sign-off.
- NYISO Update James Sweeney & Carl Patka
 - NYISO Carbon Pricing Update no report.
 - BSM & Capacity Accreditation Update presented and approved at MC meeting. Board approval required.
 - NYISO Long Island PPTN Update 19 projects received. Chart on website. Next steps – review viability and sufficiency of each project in meeting RFP objectives. ISO is reviewing what is received and will inform developers to determine if they want to proceed. Both onshore and offshore transmission needs being evaluated.
 - Interregional Transmission Planning IPSAC Planning Meeting with NE and PJM. Materials are attached.
 - Comprehensive Reliability Plan presented and approved at MC as well. BOD must approve.
- NYSRC Update Roger Clayton, NYSRC

- Last EC Meeting IRM discussed. Preliminary 19.1% approved. Last year was 20.7%. Change due to better modeling of network.
- Goal Statement for 2022. Posted on our website. Focused on high renewable impact and extreme weather event analysis. Concern over impact on reliability and review of need for new rules.
- NERC issued a level 2 alert for Cold Weather preparations for cold weather events. Need to identify critical natural gas infrastructure and avoid them being taken out of service during extreme events. NYISO responded to NERC's recommendations and has plans in place.
- Odessa Disturbance a fault caused 1000 MWs of Solar PV resources to be tripped within 200 miles of the fault. It caused a disturbance on the network. NYISO is examining possible impact of similar event on NYCA.
- Metric Update gave update on ISO reports using LOLH & EUE metrics and RAWG

- Energy Storage Proceeding 18-e-0130. September 2021 session – Order Approving Utility-Owned Asset Participation in Wholesale Markets.
- Electric Vehicle Proceeding 18-e-0138. September 2021 comments received on utilities' managed charging program proposals. EV Charging Customer Experience Working Group meeting scheduled on Nov 29.
- Offshore Wind Proceeding 18-e-0071. No report.
- Energy Efficiency and Heat Pumps 18-m-0084. September 2021 session – Order Approving Clean Energy Fund Modifications. Two extension requests granted: LMI Joint Management Committee *Manual* filing extended to Dec. 23; DPS Reporting Guidance on CEF related reporting requirements extended to Dec. 15th.
- Resource Adequacy Proceeding 19-e-0530. No report
- PSC's Transmission Planning Proceeding 20-E-0197 –
 September 2021 session Order on Local Transmission and

Distribution Planning Process and Phase 2 Project Proposals. NGRID filed petition for Phase 1 projects not in current rate case. Phase 1 projects will go through standard rate case process. Utility can petition outside rate case. Phase 2 projects will be part of a general proceeding.

NYSDEC Regulatory and State Implementation Plan Update – NYSDEC Staff

- Nearing submittal of attainment demonstration for the New York City metropolitan "serious" nonattainment area for the 2008 ozone standard. We do not attain. EPA is expected to propose reclassification to "severe" non-attainment early next year. DEC will need to develop a new attainment demonstration and is hoping that EPA will allow 18 months to do so.
- o 2015 Ozone attainment demonstration still being developed.
- SO2 non-attainment in a small portion of St Lawrence County near the Alcoa plant in Massena. Attainment demonstration is due in September 2022.DEC is working with Alcoa and EPA. Hope to complete modeling protocol that will be part of the attainment demonstration by December 2021.
