Subject: Removal of NYSRC Exceptions 17 and 18

Dear RRS,

Consolidated Edison has notified the NYSRC Executive Committee of Consolidated Edison's desire to remove Rule Exceptions 17 and 18, upon the removal from service of Indian Point Unit 2 on April 30, 2020. The NYISO's System & Resource Planning and Operations Departments have conducted a review to determine the impact of removing the exceptions. The NYISO has not identified any reliability criteria violations associated with removing the exceptions on May 1, 2020¹, as requested by Consolidated Edison.

¹ If for any reason Indian Point Unit 2 is not removed from service on April 30, 2020, as expected, the Exceptions should remain in place until Unit 2 is removed from service.
