### NYSRC Reliability Rule Reference (No. and Name)

#### I.2: Generating Unit Availability and Special Case Resource Performance

### NYSRC Requirement(s) for which compliance is being certified

**R2.** Installed Capacity Providers located in or serving the *NYCA* shall provide generating unit outage data for their generating units in accordance with *NYISO* procedures, tariffs and schedules for reporting outage data to the *NYISO*.

### Compliance Monitoring Process

#### Compliance Monitoring Responsibility:

- M2: NYISO/RCMS

#### Compliance Documentation Reporting Frequency:

- M2: Annually.

#### Compliance Reporting Requirements:

- M2: *NYISO* Certification of *LSE* Compliance

| <input type="checkbox"/> Level 2 | M2. The <i>NYISO</i> certified that generating unit outage data from an Installed Capacity Provider was found to be misreported after the data was used in <i>reliability</i> studies. |

| ___ Level 3 | M2. The <i>NYISO</i> certified that generating unit outage data from a single Installed Capacity Provider was found to be misreported two or more times over a two-year period, after the data was used in <i>reliability</i> studies. |
| ___ Level 4 | M2. The <i>NYISO</i> certified that an Installed Capacity Provider did not report its generating unit outage data in accordance with applicable <i>NYISO</i> procedures and tariffs.   |

**Notes:** Section 5.12.5 of the Market Services Tariff and Section 4.4 of the Installed Capacity Manual include requirements for ICAP resources to report outage data as part of the Generating System Data System (GADS) data submission. Section 4.4 of the Installed Capacity Manual also includes the due dates for reporting GADS data. Evidence of compliance with outage reporting requirements is available in the NxL software and in electronic files maintained by Installed Capacity Market Operations.
