### NYSRC Requirement(s) for which compliance is being certified

R3. Owners of *resources* responsible for providing *ICAP* shall seasonally verify the *net dependable capacity* of their equipment and report these results to the *NYISO* in accordance with *NYISO* procedures and schedules as required in R1.

### Levels of Non-Compliance

<input type="checkbox"/> Level 1	M2. The <i>NYISO</i> certified that one <i>Generation Owner</i> did not submit complete verified dependable net <i>capacity</i> test results to the <i>NYISO</i> as required by <i>NYISO</i> procedures and R3.
<input type="checkbox"/> Level 2	M2. The <i>NYISO</i> certified that two <i>Generation Owners</i> did not submit complete verified dependable net <i>capacity</i> test results to the <i>NYISO</i> as required by <i>NYISO</i> procedures and R3.

___ Level 3	M2. The <i>NYISO</i> certified that three <i>Generation Owners</i> did not submit complete verified dependable net test results to the <i>NYISO</i> as required by <i>NYISO</i> procedures and R3.
___ Level 4	M2. The <i>NYISO</i> certified that four or more <i>Generation Owners</i> did not submit complete verified dependable net <i>capacity</i> test results to the <i>NYISO</i> as required by <i>NYISO</i> procedures and R3.

**Notes:** This certification applies to the Winter 2014-2015 and Summer 2015 periods. Section 4.2 of the Installed Capacity Manual requires that providers of ICAP test their equipment and report the results to the NYISO. Evidence of compliance with resource capacity requirements is available in the ICAP Automated Market software. NYISO certifies that all applicable generator owners verified their DMNC and reported the results to NYISO for the capability periods of Winter 2014-2015 and summer 2015.
