NYISO reported on the LIPA loss of gas facility requirement. NYISO has certified the LIPA TOM 3004 procedure to comply with G3:R1. RCMS found the NYISO in full compliance with requirement G3:R1 for 2018. Motion by Mr. Spagnolo and seconded by Mr. Shanahan.

6.0 Additional Agenda Items

6.1 A2 compliance review of the LCR methodology

Two years ago the NYISO developed an alternative LCR methodology that was submitted to ICS. ICS developed a white paper for the NYSRC EC. The EC suggested that RRS perform a rule review of A1 and A2. RRS performed the review and modified A1 and A2 for a rule change (PRR141). The EC also identified a desire for RCMS to perform a preliminary compliance review. The approved rule change for PRR141 is not in the manual yet to perform a review but it is still an approved rule. This approved rule is also not yet part of compliance review schedule. From the ICS white paper, the EC did not approve officially but requested NYISO to pre-certify to the new methodology to verify future ability of the required compliance. NYISO states there has been no precedence to pre-certify for compliance.

Mr. Adamson agreed to research the EC minutes for an action item from two years ago to identify direction from the EC on the new LCR methodology. He will also produce a copy of the ICS white paper and the draft certification review. These will be sent to the NYISO (Mr. Grant) and to Mr. Clayton for their review and consideration on charting future direction. **(Action Item 220-1)**
