3.1 2018 Compliance Monitoring Program Update

NYISO stated the LSE entities are in full compliance. NYISO has submitted ICAP Manual section 3.4 and portions of tariff in support. RCMS found the NYISO in full compliance with requirement A.2: R4 for 2018. Motion by Mr. Spagnolo and seconded by Mr. Pandit.

NYISO stated that each of the transmission owners is in full compliance. In support, the NYISO provided excerpt from the NYISO System Restoration Manual Section 2 and 3. RCMS found the NYISO in full compliance with requirement F.1: R2 for 2018. Motion by Mr. Head and seconded by Mr. Shanahan.

3.5 Black Start Provider Requirements [F.1: R3]

NYISO stated that each black start provider is in full compliance. In support, the NYISO provided supporting evidence NYISO System Restoration procedure and information from Con Edison and NYPA. RCMS found the NYISO in full

compliance with requirement F.1: R3 for 2018. Motion by Mr. Clayton and seconded by Mr. Spagnolo.
