**2.0 Approval of Minutes/Action Items**

2.1 RCMS Draft Minutes #234

The meeting minutes for RCMS meeting #234 were reviewed and approved with minor comments on Action Items.

RCMS status report was submitted for meeting # 234 and there were no questions or comments.

### 2.3 RCMS Action Items List

Action Item 233-1: NYISO to investigate the posting of CEII material for RRS and RCMS members behind the NYISO website firewall. Mr. Grant mentioned that NYISO information security approval was received today, 9/5/19. Mr. Grant will provide a demonstration on the topic during the next meeting.

Action Item 234-1: Mr. Spagnolo to work with Mr. Adamson to determine how to reference the list of ARR at the NYSRC website. During the discussion there was a concern raised about potentially posting any CEII material in the process of listing ARR at the NYSRC website. Discussion will continue in the next RCMS meeting.

Action Items 234-2: NYISO to give NYSRC update on NPCC workshop procedures. Mr. Grant mentioned that he sits on the Board of Subcommittees of NPCC and could take any agenda item, upon NYSRC's recommendation, to NPCC for discussion. Item marked as completed.

## 3.0 NYSRC 2019 Reliability Compliance Monitoring Program

### 3.1 2019 Compliance Monitoring Program Update

The 2019 Reliability Compliance Monitoring Program, updated to include compliance reviews at the last meeting, was presented to the RCMS. Requirements G.1: R7, G.2: R2, G.2: R5 and I.3: R2 were found to be in full compliance. There were no questions or comments from the group.

Mr. Clayton proposed to RCMS members to allow for collective approval of agenda items: 3.1 to 3.6a. To be noted: RCMS members have reviewed all the items up for compliance actions carefully and have agreed that they can all be voted for as a single consent agenda. A motion to find the NYISO in full compliance for items 3.1 to 3.6a was made by Mr. Head and seconded by Mr. Ridolfino. The motion was approved.

### 3.2 July 2019 Operating Reports [C.8: R1]

The NYISO submitted July 2019 Operations Report to RCMS certifying full compliance with [C.8: R1]. RCMS found the NYISO in full compliance with requirement [C.8: R1] for July 2019. The motion was approved as stated in item 3.1 above.

### 3.3 LIPA Loss of Gas Supply Procedures and Actions [G.3: R2]

The NYISO submitted documentation and referenced PSEG Long Island's document TOM 3.004 certifying full compliance with G.3: R2. The motion was approved as stated in item 3.1 above.

3.4 SCR Performance [I.2: R4]

The NYISO submitted documentation and references to RCMS, such as 2018 July MST Section 5.12.11.1, 2019 March Installed Capacity Manual Section 4 and 2019 February DRIS Users Guide Version 3.0, certifying full compliance with [I.2: R4]. The motion was approved as stated in item 3.1 above.

3.5 RIP SCR Performance Data Reporting [I.2: R5]

The NYISO did not submit any documentation in relation to this agenda item, however, they referenced that NYISO presented the material to ICS where Mr. Adamson was also present. NYSRC agreed to accept the information in lieu of documentation provided to NYSRC. The motion was approved as stated in item 3.1 above.

3.6 Control Center Communications [H.1: R4]

The NYISO submitted documentation describing the loss of ICCP on 07/18/19 and the cause of the incident. The NYISO will also work with individual TOs and take steps so that in the future a delay in re-establishing the communications channel can be prevented. The motion was approved as stated in item 3.1 above.

3.6a NYISO Major Emergency Report 09-03-2019

The NYISO submitted the Major Emergency report to NYSRC within a day. This meets the criteria for reporting such an event within one week of the event. The motion was approved as stated in item 3.1 above.
