### 3.4. PRRs for discussion

#### 3.4.1 Tariff revision to permit inverter based resources as synchronized reserves – NYISO

Mr. Markham explained that all inverter based resources will not be able to enter the market if they are not able to meet base point criteria. Flywheels et al will have to demonstrate that they meet the regulation services and base point criteria.

There is a 1MW minimum requirement to enter the market. Also, NPCC requires them to be available for at least 1 hour to be in the market. Smaller resources can be aggregated since the test will be on the full aggregate amount. Intermittent resources like solar and wind are not allowed to enter the market to provide ancillary support.

RRS was satisfied with Mr. Markham's presentation on the technical equivalency of inverter based resources based upon test requirements and procedures. However, Mr. Shanahan suggested, ~~to~~ for a consideration, a new reliability rule and/or glossary changes that would ~~to~~ incorporate the impact of inverter based resources on the Bulk Power System~~transmission system~~. (Action Item 227-1).
