### **3.1. PRR List**

Mr. Clayton reviewed the list. PRR 146 is on today's agenda.

### **3.2. PRRs for EC final approval after posting**

#### **3.2.1. PRR 146 – B.4 Transmission System Interconnection Special Studies – R. Clayton**

Mr. Clayton presented the comments made by Herb Schrayshuen on the proposed reliability rule. NYISO responded to those comments stating that they need to look at NPCC and NERC directories associated with other rules on a more frequent basis, currently every 3 years. NYISO also stated that they cannot list specific studies as they are dependent on the scope of the project and the TO.

Mr. Schrayshuen suggested that some leeway be added to the rule for engineering judgement.

Mr. Clayton suggested that there was language needed to address the various guidelines.

Mr. Grant will revise the rule and present at the next RRS meeting (Action Item 248-1)

### **3.3. PRRs for EC approval to post for comments**

#### **3.3.1. PRR 148 – D.1 Mitigation of Major Emergencies – J. Grant (NYISO)**

Mr. Grant clarified that the rule will not go into effect until after December 1, 2020.

RRS approved PRR 148 to send to EC for posting.

### **3.4. Discussion items**

#### **3.4.1 NYCA Long-Term Reliability Risk Priorities – R. Clayton**

Mr. Clayton discussed the weighting system developed for ranking the risk priorities. Mr. Clayton requested further input from RRS members on the Reliability Risk Priorities.

#### **3.4.2 Compliance Element Revisions to Reliability Rule C.3 – A. Adamson**

Mr. Adamson stated that the EC approved the changes and they will be added to the manual at the next revision.

**3.4.3 Removal of NYSRC RR&CM Exceptions 17 & 18 – M. Paszek, J. Grant**  
Exception 8 and the retirement of IP3 need to be addressed at a future time.

**3.4.4 NYISO DER Modeling – K. DePugh, R. Clayton**

**4.1. NPCC A-10 – R. Clayton**

Mr. Clayton stated that RRS will move forward with PRR 128 as soon as the revised NPCC A-10 is approved by the NPCC Board.
