3.4.1 NYCA Long-Term Reliability Risk Priorities – R. Clayton

Mr. Clayton will distribute the NERC report and a blank matrix to RRS members to provide their own rankings. (Action Item 250-1)

3.4.2 NYISO DER Modeling – K. DePugh

Mr. DePugh gave a presentation on NYISO efforts to improve DER modeling. NYISO focus is on DER 20MW and below; as it increases it could have an impact on the BES. NYISO using composite load models for R-DERs, adding much more detail, and more complexity due to increased number of buses. R-DER test cases developed for 2020 using NYSERDA data and TO cooperation to identify DER locations. R-DER participating in NYISO markets will be required to supply model information to NYISO. For stability cases, NYISO will use explicit

control models when available, DER_A model for all others. As a result of increase in DER, summer peak may no longer be the most stressed case.

3.4.3 Removal of RR&CM Exceptions 17 & 18 – J. Grant

Indian Point Unit #2 is now retired. These exceptions are removed as of April 30. Mr. Adamson will provide an updated list of exceptions. (Action Item 250-2)
