1) Introduction

Chair Howard Kosek called the NYSRC ICS meeting to order at 10:00 A.M. on December 2, 2019.

2) Approval of Minutes for Meeting #225

- National Grid's Brian Shanahan will be the new ICS Vice Chair/Secretary next year

ICS approved Meeting #225 minutes

3) Special Sensitivity Case Results: Somerset Retirement

- Somerset submitted its Generator Retirement notice to the NY PSC

- The 675 MW unit (located in Zone A) announced that it plans to retire on or before May 13, 2020.
- In the 2020 Final Base Case, Somerset was modeled in-service.

ICS recommends the Special Sensitivity Case with Somerset Retirement as the new Final Base Case.

4) Final Draft IRM Report Body

- It was agreed that the Final IRM Report Body will be updated with the Somerset Retirement after the NYSRC Executive Committee approves the new final Base Case due to the meeting material posting requirement for the NYSRC Executive Committee meeting this Friday.
- Indicated in the report that the EFORd used is based on the market EFORd.

5) Final Draft IRM Report Appendix

- Update Appendix to align with the body of the IRM Report.

ICS recommends the Final Draft IRM Report Body and Appendix to the NYSRC Executive Committee for approval.

6) High Renewable Resource Case White Paper

- The High Renewable Resource white paper will be presented to the NYSRC Executive Committee at an upcoming meeting (Q1 2020).
- Revised some sections in the white paper based on suggested wording changes
- ICS members to submit comments to the white paper by the next ICS meeting (January 3rd).

7) Informational LCR presentation

- The informational LCR presentation was presented to the ICAP Working Group on November 21st
- Informational LCR is computed based on updated information from the Final Base Case IRM.
- Net CONE curves shifted upwards for the 2020-2021 Capability Year. Points were updated from the prior year curves by adding the change in the “Annual ICAP Reference Value” between Capability Year 2019-20 and Capability Year 2020-21 to each point on the 2019-20 cost curve. All localities saw an increase in reference price.

8) Proposed IRM Study Modeling Enhancements

- NYISO will start evaluating an updated MARS version that will fix the Study Year issue.
- NYISO will provide more details on their proposed white paper topics (i.e., level of effort, what information is needed, etc.)
- NYISO requested ICS participants to review these proposals and provide any additional topics.
- ICS will prioritize the list of white paper topics at the next meeting
