### **3.0 NYSRC Reliability Rules (RR) Development**

#### **3.1 Potential Reliability Rule (PRR) List Outstanding -R. Clayton**

- PRR 150 – Roger Clayton reached out to ICS regarding coordination with extreme weather data.
- PRR 151 – approved at last EC meeting. Is now a rule and will be incorporated into reliability rules.
- PRR 153 – In development, procedure for defining solar and wind luls.
- PRR 153a – On Agenda
- PRR 154a – Scaled down to only include unavailability of generating due to gas shortage.

#### **3.2 PRRs in development**

##### **3.2.1 PPR 153: Include “Sudden loss of fuel delivery system to multiple solar & wind plants” as a contingency in Table B-1 –R. Clayton/ K. Burrell**

- Need to clarify weather conditions as to location, time, and place
- AI – none

##### **3.2.2 PPR 153a: Include “Sudden loss of gas fuel to a plant for common mode failure of gas delivery system” as Category I & II Design Contingencies in Table B-1 –R. Clayton/ K. Burrell**

- Common mode failure issue.
- Existing Extreme contingency #10 language modified to incorporate multiple fossil plants.
- List of contingencies were viewed. No objections
- Rule can possibly be approved and implemented by May 2024 near the RNA timeframe.
- Roger Clayton will report to EC and mention that contingencies were viewed in RRS meeting and no objections to proceeding to EC.
- AI – None

**3.2.3 PRR 154a: TS Planning Performance Requirements – Include a system condition of “Peak load resulting from extreme weather” in Table B-1 –R. Clayton/ K. Burrell**

- Historical justification is during winter peak, there is stress on the gas system and plants become unavailable. This rule change reflects the conditions that Operations sees during winter peak and can be analyzed in Planning studies.
- No objections to moving this forward to EC.
- Roger Clayton will present to EC and recommend this be posted for comments.
