## **1&2 Roll Call and Request for Additional Agenda Items – H. Kosel / B. Shanahan**

- Added Policy 5 update review & approval.

### **3. Approval of Minutes for Meeting #289**

- Meeting minutes for previous meeting #289 were approved with no changes.

### **4. Review of Action Item List – H. Kosel**

- List is unchanged from previous meeting. List of Whitepaper work for this year will be updated to reflect completions and deferral of DER Modeling paper to next year, as DER data will not be available until July of this year.

### **5. Chair update on recent EC actions**

- EC determined that the Gas Constraints updates would not be a part of the PBC or FBC basecases this model year.

### **6. Gas Constraints White paper – L. Carr**

NYISO presented updated Tan45 results for varying assumed oil levels applied in the recommended fuel constraint modeling, as was requested at the May ICS meeting

- Available Oil vs Firm Oil characterization was discussed. Mr. Jordan believes that the existing “Available Oil” term is a more flexible characterization due to uncertainty regarding actual Firm vs non-Firm oil elections each year.

- Mr. Younger was concerned that if actual firm oil elections do not match model assumptions it will introduce concerns regarding market implications.
- The ICS approved the Whitepaper finalization and it will be presented to the Executive Committee at the next (June) meeting.

## **7. Tan45 Methodology Review – L. Carr**

- Updated results were presented from test cases were presented along with a summary review of the existing Tan45 process.
- ICS discussed various Cases and permutations to be studied, particularly CHPE, the LI PPTN, OSW and various Solar combinations.
- NYISO will take recommendations from today's discussion and run a reasonable set of analysis.

## **8. Alternative Load Shape Adjustment Method – M. Lucas**

NYISO provided an updated comparison between the high load hours of actual load shapes, and the high load hours of modeled load shapes that are used in the IRM study last year, with the 2013, 2017 & 2018 years that are currently used for various load bins. New load shapes will represent less energy in the system and should result in a decrease in IRM. Modeling of BTM solar as generation pending a comprehensive load modeling improvement which is a priority for 2025. Sensitivity cases will be produced this Summer prior to any implementation of changes into the 2025-26 IRM study.

Key results: [see Meeting #290 presentation, p.9]

Using the alternative load adjustment method, the IRM from last year (2024-25), would decrease by 1.4% mostly from decreased total energy requirement that is modeled in the study. Locational capacity requirements would decrease by 0.2-0.5% using the alternative method.

M. Younger and G. Jordan expressed concern that all hours should be adjusted, not just off peak hours otherwise there would be no net effect from the adjustments. There were also concerns regarding the need to further evaluate alternative load shape method prior to using for determining IRM.

Mr. Evans expressed concern that doing a monthly basis load shape adjustment will over-represent high-load levels/bins.

NYISO will continue to review the alternative load shape adjustment method with the ICS.

## **9. New Generator Inclusion Screening – A. Mohammad**

NYISO presented 3 new Solar generator's to be included in the 2025/26 IRM study, based on the inclusion criteria process. Two are in Zone C and one in Zone F for a total of ~ 347 MW total. The ICS approved inclusion of the three new generators without comment.

## **11. 2025/26 IRM PBC Parametric Results – B. Prinsloo**

- Brief update on Parametric results to date. NYISO continued updating the MARS model and performing the parametric analysis which included updating Enhanced SCR Modeling (0.57%), Shifting Wind Shapes, and 2024 Gold Book Load Forecast (+0.42%).

## **12. Additional Agenda Items**

### **Policy 5 Changes – J. Adams**

- Mr. Adams presented a redlined version of Policy 5 with recommended revisions for consideration to ensure the Policy conforms with current practice. The changes were approved by ICS and will be presented at the June EC meeting for approval.
