7.0 Additional Agenda Items

7.1 Review of NYPA’s proposed exception revisions – A. Hossain

- The consensus vote results from previous meeting were presented at the September Executive Committee meeting. Recommendation was not approved by EC and was sent back to RRS.
- NYPA has revised the proposed exception revision. Slide 7 was presented by A. Hossain.
- Discussion on whether the exception is still needed. Existing exception allowed Central-East transfer to increase. AC projects have since been put into service and exceed the MW transfer increase resulting from the existing exception. The revised exception would try to achieve further increased transfer through exceptions rather than Emergency Transfer Criteria.
- Straw vote (non-binding) was held between the RRS voting members.
 - o Motion: RRS recommends to the EC, approval of NYPA exception 1 modification request.
 - o Results:
 - Yes – (NYPA , CHGE, NYSEG)
 - No – (CONED, National Grid)
 - Abstain – (PSEGLI, Wesley Yeomans)

7.2 Discussion Regarding Under Frequency Relaying – H. Schrayshuen

- The Executive Committee suggested to present this to RRS to consider creating a NY rule to supplement the NPCC standard.
- Suggestion is to create a subcommittee within RRS to determine if a new rule needs to be developed.
