**1&2 Roll Call and Request for Additional Agenda Items – W. Gunther / B. Shanahan**

**3. Approval of Previous Meeting Minutes**

Meeting minutes for previous meeting #297 were approved with minor comments incorporated.

**4. Review of Action Item List – W. Gunther**

No new items were presented. Action Item 220-1, there were no Transmission Owners that reported any Public Appeals for load reduction

**Chair update on recent EC actions**

The EC approved the Table 6-1 and the Table 7-1 Sensitivity Analysis List. EC requested that we round to 2 decimal places vs 3 places in the Tables. The Draft IRM Reports, BTM Solar Whitepaper and Tan45 whitepapers were reviewed by the EC. The EC was supportive of offshore wind hourly shapes being considered in the future. NYISO will be working with NPCC to accomplish this.

**5. Tan45 Methodology Review Whitepaper – L. Carr**

NYISO presented the Tan 45 methodology whitepaper which summarizes this year's work identifying potential issues with the Tan 45 methodology and will be followed by another study in 2025 looking at potential solutions. It was observed that Tan 45 failed when significant amounts of capacity were added downstate via OSW and CHPE. Large capacity additions downstate (without significant load growth) will likely trigger corresponding fossil retirements, which would avoid significant excess capacity downstate. ICS approved the Tan45 Whitepaper, based on the inclusion of a statement to address Mr. Younger's suggested review of shifting methodology (shifting via effective capacity of average thermal, etc.).

**6. 2025 IRM Study Technical Report – G. Jordan**

Gary Jordan presented the red lined third/final draft of the 2025 IRM Report. The EC recommendation of the results in Tables 6 and 7 being displayed to 2 decimal places was incorporated. Mr. Schrayshuen noted that the EC actually votes on an IRM to one decimal place. The final version will be provided to the Executive Committee for its December meeting. Minor editorial comments were suggested, and the 2025-26 Technical Report was approved by ICS.

**7. 2025 IRM Study Technical Report Appendices – J. Adams**

The updated draft Technical Report Appendices were presented by John Adams. A few minor editorial changes were included from the previous draft. The date and removal of draft status will be updated. The 2025-26 Technical Report Appendices were approved by the ICS.

**8. Additional Agenda Items**

A potential ICS Conference call could be necessary in January if an IRM is approved by the EC that varies from the calculated IRM.
